#### ORDER

By this Order, the commission orders that certificate of public convenience and necessity no. 5127-C ("Certificate No. 5127-C"), held by GEORGE N.K. PUA, SR., dba B & N TRUCKING ("Petitioner"), is revoked and this docket is closed.

#### Request to Place Common Carrier Authority on Inactive Status

By Order No. 20829, filed on February 27, 2004, Certificate No. 5127-C, held by Petitioner, was placed on inactive status until February 27, 2005.

Order No. 20829 informed Petitioner that if Certificate No. 5127-C was not reactivated prior to the expiration of the period of inactivity, i.e., prior to February 27, 2005, including filing all documents necessary for reactivation, the commission would deem it to be abandoned and revoked. Order No. 20829 also informed Petitioner that he may file, prior to the expiration of the period of inactivity, a request to extend his inactive status for up to one additional year.

### Findings and Conclusions

Certificate No. 5127-C was not reactivated prior to February 27, 2005, and the Petitioner did not file a request to extend his inactive status prior to February 27, 2005. Accordingly, we find that there is good cause to revoke Certificate No. 5127-C.
