ORDER

The commission approves HAWAII WATER SERVICE COMPANY, INC.'s ("HWSCI") requests for additional time to file its new proposed rate design for the commission's review and approval.

HWSCI requests: (1) an additional extension of time, from March 24, 2005 to April 8, 2005, to file its new proposed rate design for the commission's review and approval; and (2) a corresponding extension of time, from March 30, 2005 to April 14, 2005, for the Division of Consumer Advocacy ("Consumer Advocate")(collectively, the "Parties") to file its comments on HWSCI's new proposed rate design.¹

HWSCI states that, following the Consumer Advocate's review and comments on HWSCI's draft proposed rate design, it requests additional time to discuss a possible stipulation. In

addition, HWSCI represents that the Consumer Advocate concurs with HWSCI's requests.²

The commission grants HWSCI's requests for additional time, pursuant to Hawaii Administrative Rules §§ 6-61-23(a)(1) and 6-61-41. Accordingly, the new deadline dates are:

1. April 8, 2005: Deadline for HWSCI to file its new proposed rate design for the commission's review and approval.
2. April 14, 2005: Deadline for the Consumer Advocate to file its comments to HWSCI's new proposed rate design.
3. April 8, 2005: Deadline for the Parties to file a joint, stipulated filing for the commission's review and approval, in lieu of paragraphs 1 and 2, above.

THE COMMISSION ORDERS that HWSCI's requests for additional time are granted. The new deadline dates are:


1. April 8, 2005: Deadline for HWSCI to file its new proposed rate design for the commission's review and approval.
2. April 14, 2005: Deadline for the Consumer Advocate to file its comments to HWSCI's new proposed rate design.
3. April 8, 2005: Deadline for the Parties to file a joint, stipulated filing for the commission's review and approval, in lieu of paragraphs 1 and 2, above.


