ORDER

By this Order, the commission approves the request by the Operating Engineers Local Union No. 3 ("Local 3") for an enlargement of time, pursuant to Hawaii Administrative Rules ("HAR") § 6-61-23, to file a motion to intervene in or participate in the instant proceeding.

I.

Background

By an application filed on January 31, 2005, GRACE PACIFIC CORPORATION ("Applicant") (together with Local 3, the "Parties"), requests approval from the commission for a transfer of its certificate of public convenience and necessity number 222-C ("Certificate No. 222-C") to Ace Trucking, Inc. ("Application"). Applicant's request is made pursuant to Hawaii Revised Statutes ("HRS") § 271-18.

On April 4, 2005, Local 3 filed a motion to enlarge time to file a motion to intervene or participate in proceedings ("Motion to Enlarge Time"), in accordance with HAR § 6-61-23.

On April 8, 2005, Applicant filed a memorandum in opposition to the Motion to Enlarge Time ("Memorandum in Opposition").

On April 13, 2005, Local 3 filed a reply memorandum to Applicant's Memorandum in Opposition in which it requested that the commission grant the Motion to Enlarge Time or otherwise give Local 3 an opportunity to brief the commission of the potential negative consequences on Applicant's employees should the commission approve the Application ("Local 3 Reply").

On April 18, 2005, Applicant filed a supplemental opposition memorandum to the Motion to Enlarge Time ("Supplemental Opposition").

II.

HAR §§ 6-61-23 and 6-61-57

HAR § 6-61-23(a)(1) provides that the commission may, at any time and in its discretion, on a showing of good cause, enlarge the period of time for any act that is required to be

done when a written request for the enlargement of time is filed before the expiration of the originally prescribed period.

In the instant proceeding, the originally prescribed period is set forth in HAR § 6-61-57(2). In relevant part, it provides that motions to intervene, to be timely, shall be filed and served not later than twenty (20) days after a notice of the pending application has been published in the newspaper. In the instant case, thus, twenty (20) days after the published notice of the pending Application is April 4, 2005. Local 3's Motion to Enlarge Time was filed with the commission on April 4, 2005. Thus, Local 3's Motion to Enlarge Time is timely, as it was filed before the expiration of the prescribed period.

III.

Discussion

HAR § 6-61-23 gives the commission discretion, upon a showing of good cause, to grant a motion for enlargement of time if a written request is made prior to the expiration of the prescribed period.

Local 3 represents that it became aware of the Application on March 30, 2005, and of the deadline for filing a motion to intervene on April 4, 2005. In its Memorandum in Opposition, Applicant questions Movant's failure to timely file either a motion to intervene after March 30, 2005, or a motion to

enlarge the time to file prior to April 4, 2005. Applicant also questions the timing of Local 3's awareness of relevant filing deadlines and the veracity of Local 3's assertions in its Motion to Enlarge Time.

Upon review, the commission finds that Local 3 has established good cause for the commission to approve its Motion to Enlarge Time, pursuant to HAR § 6-61-23(a)(1) and, thus, concludes that the Motion to Enlarge Time should be approved. Local 3 is required to file any motion to intervene or participate in the instant proceeding within ten (10) days from the date of this Order.

IV.

Orders

THE COMMISSION ORDERS:

- 1. Local 3's Motion to Enlarge Time, filed on April 4, 2005, is approved.
- 2. Local 3 shall file any motion to intervene or participate within ten (10) days from the date of this Order.
