By this Order, the commission orders that certificate of public convenience and necessity no. 1744-C ("Certificate No. 1744-C"), held by TAM CHI NGUYEN ("Petitioner"), is revoked and this docket is closed.

## Request to Place Common Carrier Authority on Inactive Status

By Order No. 20873, filed on March 29, 2004, Certificate No. 1744-C, held by Petitioner, was placed on inactive status until March 29, 2005.

Order No. 20873 informed Petitioner that if Certificate No. 1744-C was not reactivated prior to the expiration of the period of inactivity, i.e., prior to March 29, 2005, the commission would deem it to be abandoned and revoked. On March 31, 2005, Petitioner filed a request to voluntarily surrender his certificate ("Request to Surrender").

## Findings and Conclusions

Certificate No. 1744-C was not reactivated prior to March 29, 2005. Accordingly, we find that there is good cause to revoke Certificate No. 1744-C. Since the period of inactivity expired on March 29, 2005, the commission also deems the Request to Surrender moot.
