## DECISION AND ORDER

By this Decision and Order, the commission denies the request of CONCRETE CORING CO. OF HAWAII, INC. ("Applicant") for temporary authority to operate as a common carrier of property by motor vehicle in the general commodities and dump truck classifications over irregular routes on the island of Hawaii.

I.

#### Application for Temporary Common Carrier Authority

On March 16, 2005, Applicant filed an application requesting temporary authority to operate as a common carrier of property by motor vehicle over irregular routes on the island of Hawaii in the general commodities and dump truck classifications. The application is made pursuant to Hawaii Revised Statutes ("HRS") § 271-16. Applicant currently is the holder of certificate of public convenience and necessity number 2115-C, which authorizes Applicant to transport property by motor vehicle over irregular routes on the island of Oahu in the dump truck classification.

# Findings and Conclusions

For a grant of temporary operating authority pursuant to HRS § 271-16, an applicant must satisfy two conditions. First, the applicant must establish that there is "an immediate and urgent need" for the proposed service. Second, the applicant must demonstrate "[an] absence of carrier service capable of meeting the need between points or in the territory where the temporary service will be instituted." <u>See In re Robert's Tours & Transportation, Inc.</u>, Decision and Order No. 15274, Docket No. 96-0437 (December 23, 1996). Moreover, the commission may, at its discretion, grant temporary authority without hearings or other proceedings. HRS §271-16.

Based upon our review of the application, we find that Applicant does not meet the criteria for temporary authority set forth in HRS § 271-16. Applicant has not demonstrated that there is an immediate and urgent need for its motor carrier service, nor has it shown that no other motor carrier is able to provide the motor carrier service proposed by Applicant. Thus, the commission concludes that Applicant's request for a temporary motor carrier certificate should be denied.

# III.

#### <u>Orders</u>

### THE COMMISSION ORDERS:

1. Applicant's request for temporary authority to operate as a common carrier of property by motor vehicle over
