<u>ORDER</u>

By this Order, the commission allows the revised tariff sheets and newly revised tariff, filed on April 20, 2005 by HAWAII WATER SERVICE COMPANY, INC. ("HWSC" or "HWSCI"), as amended, to take effect from April 22, 2005; provided that, if there are any changes incorporated in HWSCI's newly revised tariff that are not specifically approved by this Order, such changes are null, void, and of no effect.¹

On April 15, 2005, the commission: (1) approved the Parties' primary rate design, as proposed in their Stipulated Rate Design, filed on April 8, 2005; and (2) noted that HWSCI's increase in rates and revised tariff sheets were to take effect from April 22, 2005.² The commission also instructed HWSCI as follows:

HWSCI's revised tariff sheets and schedules, with the applicable issued effective dates, shall be filed with commission and served upon the Consumer Advocate within three (3) business days from the date of this Order. The revised tariff sheets incorporate the revisions approved by commission in Decision and Order No. 21644, Section X, and the rate schedule shall incorporate the rate design approved by this Order.

On April 20, 2005, HWSCI submitted its revised tariff sheets and new rate schedules (collectively, the "revised tariff sheets"). HWSCI's revised tariff sheets are consistent with Decision and Order No. 21644 and Order No. 21751, and took effect on April 22, 2005, in accordance with Order No. 21751.

HWSCI, on its own accord, also revised and filed an entirely new tariff that incorporates its revised tariff sheets ("newly revised tariff"). HWSCI explains:

. . . Attached hereto is HWSC's revised tariff. In addition to the rate changes and other tariff changes approved by the Commission, HWSC has revised the entire tariff to reflect the change of its name from Kaanapali Water Corporation to Hawaii Water Service Company, Inc. 6

On March 4, 2004, HWSCI filed in this docket a complete copy of its existing tariff for informational purposes.

After reviewing HWSCI's newly revised tariff, the commission finds that it incorporates the: (1) commission's approved changes in the revised tariff sheets; (2) change in name from Kaanapali Water Corporation to HWSCI; and (3) numbering changes resulting from HWSCI's newly revised tariff.

HWSCI represents that no other changes are included in its newly revised tariff. Based solely on HWSCI's representation, the commission will allow the change in name and related numbering changes included in HWSCI's newly revised tariff to take effect on short notice, upon a finding of good cause shown, consistent with Hawaii Revised Statutes § 269-16(b) and Hawaii Administrative Rules § 6-61-112; provided that, if there are any changes incorporated in HWSCI's newly revised tariff that are not specifically approved by this Order, such changes are null, void, and of no effect.

The change in name and related numbering changes

included in HWSCI's newly revised tariff, filed on April 20,

2005, are allowed to take effect on short notice, effective from

April 22, 2005; provided that, if there are any changes

incorporated in HWSCI's newly revised tariff that are not

specifically approved by this Order, such changes are null, void,

and of no effect.

In the event of a conflict between any provision

of HWSCI's newly revised tariff and State of Hawaii ("State")

law, State law shall prevail.
