By this Order, the commission orders that certificate of public convenience and necessity no. 5186-C ("Certificate No. 5186-C"), held by GASPAR TRUCKING, LLC ("Petitioner"), is revoked and this docket is closed.

Request to Place Common Carrier Authority on Inactive Status

By Order No. 20937, filed on April 30, 2004, Certificate No. 5186-C, held by Petitioner, was placed on inactive status until April 30, 2005.

Order No. 20937 informed Petitioner that if Certificate No. 5186-C was not reactivated prior to the expiration of the period of inactivity, i.e., prior to April 30, 2005, the commission would deem it to be abandoned and revoked.

Certificate No. 5186-C was not reactivated prior to April 30, 2005. Accordingly, we find that there is good cause to revoke Certificate No. 5186-C.

Orders


THE COMMISSION ORDERS that Certificate No. 5186-C is revoked, and this docket is closed.


