ORDER

The commission approves the voluntary surrender of UNITED STATES ADVANCED NETWORK, INC.'s ("Petitioner") certificate of authority ("COA") to operate as a reseller of intrastate telecommunications services.

Petitioner holds a COA to operate as a reseller of intrastate telecommunications services. Petitioner was issued COA No. 99-0036 by the commission.
