#### <u>ORDER</u>

The commission approves the voluntary surrender of ECONODIAL, LLC's ("Petitioner") certificate of authority ("COA") to operate as a reseller of intrastate telecommunications services.

Petitioner holds a COA to operate as a reseller of intrastate telecommunications services.¹ Petitioner requests the commission's approval to voluntarily surrender its COA, by letter dated December 22, 2004, filed on December 30, 2004. Petitioner, as part of its request, paid its public utility fee for December 2004. To date, Petitioner has not submitted a complete version of its 2004 annual financial report or its public utility fee based on its 2004 revenues.

Nonetheless, the commission: (1) approves the voluntary surrender of Petitioner's COA; and (2) waives the customer

notification requirement set forth in Hawaii Administrative Rules ("HAR") § 6-80-123(a).<sup>2</sup>

#### THE COMMISSION ORDERS:

- 1. Petitioner's request to surrender its COA to operate as a reseller of intrastate telecommunications services is approved, effective from the date of this Order.
- 2. The customer notification requirement set forth in HAR  $\S$  6-80-123(a) is waived.
