Request to Place Common Carrier Authority on Inactive Status

By Order No. 21075, filed on June 23, 2004, Certificate No. 5691-C, held by Petitioner, was placed on inactive status until June 23, 2005.

Order No. 21075 informed Petitioner that if Certificate No. 5691-C was not reactivated prior to the expiration of the period of inactivity, i.e., prior to June 23, 2005, the commission would deem it to be abandoned and revoked.
