Certificate No. 1682-C was not reactivated prior to June 29, 2005. Accordingly, we find that there is good cause to revoke Certificate No. 1682-C.




Orders

THE COMMISSION ORDERS that Certificate No. 1682-C is revoked, and this docket is closed unless otherwise ordered by the commission.




