#### <u>ORDER</u>

By this Order, the commission orders that Decision and Order No. 21402 is voided and this docket is closed.

I.

#### Application for Common Carrier Authority

On October 7, 2004, in Decision and Order No. 21402, approved the application the commission of GGM TOURS ("Applicant") for a certificate of public convenience and necessity to operate as a common carrier of passengers by motor vehicle over irregular routes on the island of Oahu in the 8-to-25 passenger classification. We also: (1)ordered Applicant, as a condition to our approval of the application, to comply with all commission requirements for common carriers, including submitting certain documents within one hundred and twenty (120) days of the issuance of the decision and order; and (2) notified Applicant that failure to timely comply with the commission's requirements would constitute cause for the commission to void the Decision and Order. We served Applicant

with a copy of the Decision and Order by mail, postage prepaid, on the same day that the Decision and Order was issued, in accordance with Hawaii Administrative Rules §§ 6-61-21 and 6-61-122. Additionally, we sent a letter to Applicant, dated October 7, 2004, which reiterated the commission's requirements and specified February 7, 2005, as the deadline for compliance.

On January 4, 2005, Applicant filed a request with the commission for a sixty (60)-day extension to comply. The request was approved on January 5, 2005, which allowed Applicant until April 7, 2005 to comply. On March 21, 2005, Applicant filed a request for an additional sixty (60)-day extension to comply. The request was approved on March 24, 2005, which allowed Applicant until June 7, 2005 to comply.

II.

#### Findings and Conclusions

The extended due date has passed, and Applicant has not complied with the requirements set forth in Decision and Order No. 21402. The commission, thus, determines that Decision and Order No. 21402 should be voided.

III.

#### Orders

THE COMMISSION ORDERS that Decision and Order No. 21402 is voided and this docket is closed unless otherwise ordered by the commission.
