Request to Place Common Carrier Authority on Inactive Status

By Order No. 21025, filed on June 3, 2004, Certificate No. 892-C, held by Petitioner, was placed on inactive status until July 14, 2005.

Order No. 21025 informed Petitioner that if Certificate No. 892-C was not reactivated prior to the expiration of the period of inactivity, i.e., prior to July 14, 2005, the commission would deem it to be abandoned and revoked.




THE COMMISSION ORDERS that Certificate No. 892-C is revoked, and this docket is closed unless otherwise ordered by the commission.


