By this Order, the commission orders that certificate of public convenience and necessity no. 1406-C ("Certificate No. 1406-C"), held by MINH NGOC HUYNH ("Petitioner"), is terminated, effective from the date of this Order.

I.

Request to Surrender Common Carrier Authority

By Order No. 21303, filed on August 13, 2004, in this docket, Certificate No. 1406-C, held by Petitioner, was placed on inactive status until August 13, 2005. On July 20, 2005, Petitioner filed a letter requesting commission approval to voluntarily surrender his authority under Certificate No. 1406-C. Under Certificate No. 1406-C, Petitioner is authorized to transport passengers by motor vehicle over irregular routes on the island of Oahu in the 8-to-25 passenger classification, limousines. As his limited to part of request, Petitioner returned Certificate No. 1406-C to the commission.

Findings and Conclusions

In accordance with Hawaii Revised Statutes ("HRS") § 271-19, operating authority under a certificate of public convenience and necessity may be terminated upon application of the holder. The commission finds good cause to grant Petitioner's request to terminate his authority.

THE COMMISSION ORDERS:

- 1. Petitioner's authority to transport passengers under Certificate No. 1406-C is terminated, effective from the date of this Order.
- 2. Petitioner shall remove any markings from the vehicles used in his operations. Petitioner shall comply with the foregoing requirement within fifteen (15) days from the date of this Order.
- 3. If Petitioner fails to comply with the foregoing requirement within the time period specified, he may be subject to penalties pursuant to HRS § 271-27.
- 4. This docket is closed unless otherwise ordered by the commission.
