Request to Place Common Carrier Authority on Inactive Status

By Order No. 21380, filed on September 29, 2004, Certificate No. 1040-C, held by Petitioner, was placed on inactive status until August 22, 2005.

Order No. 21380 informed Petitioner that if Certificate No. 1040-C was not reactivated prior to the expiration of the period of inactivity, i.e., prior to August 22, 2005, the commission would deem it to be abandoned and revoked.

Findings and Conclusions

Certificate No. 1040-C was not reactivated prior to August 22, 2005.¹ Accordingly, we find that there is good cause to revoke Certificate No. 1040-C.
