BEELINE LONG DISTANCE, LLC, dba HELLO TELECOM ("Petitioner"), holds a certificate of authority ("COA") to operate as a reseller of intrastate telecommunications services.¹ Petitioner requests the commission's approval to voluntarily surrender its COA, by letter filed on December 30, 2004. Petitioner represents that it has "not done business in your state and do not plan to in the future."²

On July 25, 2005, Petitioner complied in full with the commission's directive, dated January 12, 2005, by submitting its 2003 and 2004 annual financial reports and paying the applicable public utility fees.

Given its non-provision of telecommunications services in the State of Hawaii, the commission: (1) approves the voluntary surrender of Petitioner's COA; and (2) waives the customer notification requirement set forth in Hawaii Administrative Rules ("HAR") § 6-80-123(a).
