#### ORDER

By this Order, the commission orders that Decision and Order No. 21585 is voided and this docket is closed.

### Application for Common Carrier Authority

On February 3, 2005, in Decision and Order No. 21585, the commission approved the application of AMA LEGAL CORP. ("Applicant") for a certificate of public convenience and necessity to operate as a common carrier of passengers by motor vehicle over irregular routes on the island of Oahu in the 8-to-25 passenger classification. We also: (1) Applicant, as a condition to our approval of the application, to comply with all commission requirements for common carriers, including submitting certain documents within one hundred and twenty (120) days of the issuance of the decision and order; and (2) notified Applicant that failure to timely comply with the commission's requirements would constitute cause for the commission to void the Decision and Order. We served Applicant with a copy of the Decision and Order by mail, postage prepaid, on the same day that the Decision and Order was issued, in accordance with Hawaii Administrative Rules §§ 6-61-21 and 6-61-122. Additionally, we sent a letter to Applicant, dated February 3, 2005, which reiterated the commission's requirements and specified June 3, 2005, as the deadline for compliance.

On June 3, 2005, Applicant filed a request for an extension of time to comply with our requirements. The request was approved on June 6, 2005, which allowed Applicant until August 3, 2005 to comply.

II.

#### Findings and Conclusions

The extended due date has passed, and Applicant has not complied with the requirements set forth in Decision and Order No. 21585. The commission, thus, determines that Decision and Order No. 21585 should be voided.

III.

#### Orders

THE COMMISSION ORDERS that Decision and Order No. 21585 is voided and this docket is closed unless otherwise ordered by the commission.
