#### ORDER

On February 8, 2005, AALA TRANSPORTATION COMPANY, INC. ("Applicant") filed an application requesting a permit ("Permit") to operate as a contract carrier of passengers by motor vehicle the island irregular routes on of Oahu in the over 8-to-25 passenger classification, pursuant to contracts with Transmarine Navigation Corporation and Norko Marine Agency, Inc. By Decision and Order No. 21831, filed on May 19, 2005, the commission granted Applicant a Permit subject to certain requirements.
