ORDER

By this Order, the commission approves the Stipulation to Dismiss Formal Complaint with Prejudice ("Stipulation") filed on July 13, 2005 by JAMES RUSSELL BERG and PATRICIA JO BERG ("Complainants") and PRINCEVILLE UTILITIES COMPANY, INC. ("Respondent") (Complainants and Respondent are collectively referred to as the "Parties").

I.

Background

On November 15, 2004, Complainants filed a complaint against Respondent, pursuant to Hawaii Administrative Rules ("HAR") chapter 6-61, subchapter 5. Complainants alleged, among other things, that Respondent violated an agreement dated April 29, 1997 when Respondent transferred a contribution-in-aid-

of-construction credit / meter fee waiver from Lot 10, Unit A of Anini Vista Estates Subdivision to Lot 5, Unit C.

On December 17, 2004, the commission issued Order No. 21496, requiring Respondent to either: (1) satisfy the matters complained of and file an answer reporting that it has satisfied the matters raised in the Complaint; or (2) file an answer to the Complaint within twenty (20) days of service of Order No. 21496.

On January 10, 2005, Respondent filed a Motion to Dismiss ("Motion to Dismiss"), pursuant to HAR §§ 6-61-41 and 6-61-69 or, in the alternative, an answer to the Complaint in accordance with Order No. 21496, pursuant to HAR § 6-61-68. Complainants filed their response to Respondent's Motion to Dismiss on January 19, 2005. By Order No. 21834 filed on May 20, 2005, the commission denied Respondent's Motion to Dismiss, and ordered the Parties to participate in mediation prior to the commencement of a hearing on the Complaint.

On July 13, 2005, the Parties filed the Stipulation, stating that the Parties "have conducted informal discussions to resolve this matter amicably and have reached an agreement to resolve this matter." The Complainants agreed to dismiss the

Complaint with prejudice, and the Parties agreed that the Stipulation "resolves all claims, damages, and injuries of every kind, known and unknown, now and in the future which the [P]arties may have with respect to the matters raised in the [Complaint]."⁵

Upon review of the entire record, the commission will:

(1) approve the Parties' agreement to dismiss the Complaint with prejudice, as set forth in the Stipulation filed on July 13, 2005; and (2) close the instant docket.

II.

<u>Orders</u>

THE COMMISSION ORDERS:

- 1. The Parties' Stipulation filed on July 13, 2005 and the agreement therein to dismiss the Complaint with prejudice, filed on November 15, 2005, is approved.
- 2. This docket is closed, unless ordered otherwise by the commission.
