ORDER

THE COMMISSION APPROVES the request of NORTH SHORE WASTEWATER TREATMENT, L.L.C. ("NSWT") and KUILIMA RESORT COMPANY ("KRC") (collectively, "Respondents") for an extension of time, from October 25, 2005 to November 8, 2005, to file their direct testimonies and exhibits, upon a finding of good cause shown under Hawaii Administrative Rules § 6-61-23(a)(1).<sup>1</sup> The Parties: (1) have exchanged certain information and held discussions that may lead to the resolution of some or all of the issues; and (2) believe that the additional time will enable them to explore
