ORDER

commission: By this order, the (1)approves Hess Microgen, LLC's ("Hess Microgen") withdrawal from this proceeding; (2) dismisses Johnson Controls, Inc. ("JCI") as a Party; and (3)amends the regulatory schedule for this proceeding.

I. <u>Discussion</u>

A. Hess Microgen's Notice of Withdrawal

On September 19, 2005, Hess Microgen filed a notice of withdrawal in this docket. The commission approves Hess Microgen's withdrawal from this proceeding.

B. Dismissal of JCI

On June 16, 2005, the commission filed a Notice of Intent to Dismiss Johnson Controls, Inc. ("JCI") as a Party to this proceeding because JCI had failed to participate in this proceeding in accordance with the commission's orders and its continued involvement as a Party would unduly delay the proceeding. JCI has not filed any written objection to the commission's Notice of Dismissal. Accordingly, the commission dismisses JCI as a Party to this proceeding.

C. Scheduling Order

Due to scheduling conflicts, the commission amends the regulatory schedule by moving the panel hearings from the week of October 17, 2005, to the week of December 12, 2005. The Parties¹ notified the commission's staff that they do not object to this schedule change.

On September 20, 2005, Hawaiian Electric Company, Inc. ("HECO"), with the concurrence of all Parties, requested that the regulatory schedule be amended as follows:
