### ORDER

The commission approves the voluntary surrender of LOEA COMMUNICATIONS CORPORATION'S ("Petitioner") certificate of authority ("COA") 01-0213.

Petitioner holds a COA to operate as a provider of facilities-based intrastate telecommunications services. Petitioner was issued COA 01-0213 by the commission.

Petitioner requests the commission's approval to voluntarily surrender its COA, by letter dated September 23, 2005. Petitioner represents that it intends to dissolve, and "currently does not have any customers." On October 10, 2005, Petitioner filed its 2005 Annual Financial Report and paid its related public utility fees, in response to the commission's directive.

The commission: (1) approves the voluntary surrender of Petitioner's COA 01-0213; and (2) waives the customer notification requirement set forth in Hawaii Administrative Rules
