#### <u>ORDER</u>

By this Order, the commission grants the joint request of HAWAIIAN ELECTRIC COMPANY, INC. ("HECO"), the DIVISION OF CONSUMER ADVOCACY, DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS Advocate"), and the DEPARTMENT OF THE ("Consumer NAVY, OF THE DEPARTMENT OF DEFENSE ("DoD") (HECO, ON BEHALF Consumer Advocate, and DoD are collectively referred to as the "Parties") for an extension of time from November 25, 2005, until December 2, 2005, to file simultaneous opening briefs, and from December 16, 2005, until December 19, 2005, to file simultaneous reply briefs.

I.

#### Background

Order No. 21727, issued on April 8, 2005, among other things, established the schedule of proceedings for this docket. Pursuant to the schedule of proceedings, the Parties must submit simultaneous opening briefs four (4) weeks after the transcripts from the evidentiary hearing are available. The Parties must

submit simultaneous reply briefs three (3) weeks after the filing of the opening briefs.

On October 27, 2005, the Commission sent a Notice to Parties of Receipt of Official Transcript. On October 31, 2005, the commission set the following deadlines for the filing of the post-hearing briefs: November 25, 2005, for the filing of simultaneous opening briefs and December 16, 2005, for the filing of simultaneous closing briefs

On November 18, 2005, the Parties requested an extension of time until December 2, 2005, and December 19, 2005, to file their opening and reply briefs, respectively.

II.

#### Discussion

Hawaii Administrative Rules ("HAR") § 6-61-23(a)(1) provides the commission with the discretion, for good cause shown, to enlarge a period by which a required act must be completed, if a written request is made before the expiration of the period originally prescribed. By letter filed on November 18, 2005, prior to expiration of the extension period, the Parties requested an extension. The Parties state "[d]ue to scheduled evidentiary hearings for other docketed matters in November and December, the Consumer Advocate and HECO amended schedule to prepare their respectfully request an respective [o]pening and [r]eply [b]riefs. In addition, providing a deadline on the day after Thanksgiving presents

staffing concerns for the Consumer Advocate." Based on the foregoing, the commission finds good cause in this instance to enlarge the deadline by which the Parties must file their opening and reply briefs, and grants their request for extension of time.

#### <u>Order</u>

THE COMMISSION ORDERS that the Parties' request for an extension of time by which they must file their respective opening and reply briefs is granted. Unless otherwise ordered, the Parties shall file their opening briefs on December 2, 2005, and their reply briefs on December 19, 2005.
