Application to Extend Common Carrier Authority

On March 3, 2005, Applicant filed an application seeking commission approval to extend its authority under Certificate No. 4860-C to include the 8-to-25 passenger classification on the island of Maui.

By a notice of dismissal dated October 6, 2006, we informed Applicant of our intent to dismiss the application without prejudice because of Applicant's failure to respond to the commission's request for information. Applicant was further advised that any objection to the dismissal of its application must be submitted in writing and filed not later that ten (10) days from the date of the notice, and that if an

objection was not filed, the commission would issue an order dismissing the application.

Findings and Conclusions

Applicant did not object to the dismissal of its application within the ten (10)-day time period. We, thus, find that there is good cause to dismiss the application in this docket.
