#### **ORDER**

By this Order, the commission orders that certificate of public convenience and necessity no. 1236-C ("Certificate No. 1236-C"), held by JANE YEH ("Petitioner"), is terminated, effective from the date of this Order.

I.

## Request to Surrender Common Carrier Authority

On April 4, 2005, Petitioner filed a letter requesting commission approval to voluntarily surrender her authority under Certificate No. 1236-C. Under Certificate No. 1236-C, Petitioner is authorized to transport passengers by motor vehicle over irregular routes on the island of Oahu in the 1-to-7 passenger classification.

## Findings and Conclusions

In accordance with Hawaii Revised Statutes ("HRS") § 271-19, operating authority under a certificate of public

convenience and necessity may be terminated upon application of the holder. The commission finds good cause to grant Petitioner's request to terminate her authority.

III.

### Orders

#### THE COMMISSION ORDERS:

- 1. Petitioner's authority to transport passengers under Certificate No. 1236-C is terminated, effective from the date of this Order.
- 2. Petitioner shall surrender her certificate and remove any markings from the vehicles used in her operations. Petitioner shall comply with the foregoing requirement within fifteen (15) days from the date of this Order.
- 3. If Petitioner fails to comply with the foregoing requirement within the time period specified, she may be subject to penalties pursuant to HRS § 271-27.
- 4. This docket is closed unless otherwise ordered by the commission.

¹At the same time, we note that Petitioner has not filed her 2005 AFR and applicable fee for the period from January 1, 2005 to April 4, 2005 (the date that Petitioner's request was filed) pursuant to our written requests of May 13, 2005 and October 17, 2005. Thus, should Petitioner in the future request authority to operate as a motor carrier, she will need to first, if she has not yet done so, satisfy this matter before her application is reviewed by the commission.
