## Request to Amend Common Carrier Authority

By Decision and Order No. 21936, filed on July 21, 2005, R K CONTRACTING, LLC ("Applicant") was granted a certificate of public convenience and necessity to operate as a common carrier of property by motor vehicle over irregular routes on the island of Oahu in general commodities and dump truck classifications.

On November 21, 2005, Applicant filed a letter requesting that its authority in the general commodities classification be surrendered. Accordingly, we find good cause to grant Applicant's request and amend Decision and Order No. 21936 to reflect such surrender of authority.

## THE COMMISSION ORDERS:

- Applicant's request to surrender its authority in the general commodities classification is granted.
- Decision and Order No. 21936 is amended consistent 2. with the terms of this Order. Specifically, ordering paragraph 1 in Decision and Order No. 21936 is amended as follows:

"Applicant is granted a Certificate to operate as a common carrier of property by motor vehicle over irregular routes on the island of Oahu in the dump truck classification."

In all other respects, Decision and Order No. 21936 remains unchanged.
