ORDER

By this Order, the commission instructs HAWAIIAN ELECTRIC COMPANY, INC., HAWAII ELECTRIC LIGHT COMPANY, INC. ("HELCO"), MAUI ELECTRIC COMPANY, LIMITED (collectively, "Applicants") and the Department of Commerce and Consumer Affairs, Division of Consumer Advocacy ("Consumer Advocate"), to submit a stipulated procedural schedule for the commission's review and consideration within thirty (30) days of the date of this Order. Alternatively, in the absence of a formal procedural schedule, each Party shall submit a proposed procedural schedule for the commission's consideration by the same date.

¹Applicants and the Consumer Advocate are collectively referred to as the "Parties."

Background

2006, Applicants jointly filed an On January 3, Application with the commission that seeks the commission's approval of various matters related to Item P0001010, purchase and installation of a Human Resources Suite System ("HR Suite Project"). Applicants specifically request commission's approval to: (1) defer certain computer software development costs and to commit funds in excess of \$2,500,000 (excluding customer contributions) for the HR Suite Project; (2) accumulate during the deferral period an allowance for funds used during construction ("AFUDC"); (3) amortize the deferred costs, including AFUDC, over a twelve (12)-year period, or such other amortization period the commission finds reasonable; and (4) include the unamortized deferred costs, including AFUDC, in rate base.2

On January 19, 2006, the Consumer Advocate filed its Preliminary Statement of Position, based on its initial review of the Application. The Consumer Advocate identified certain questions and concerns, and stated its intent to participate in this docket, including the issuance of information requests and the filing of its Final Statement of Position, upon the completion of its investigation.³

Given that the commission's ruling in this docket may possibly affect HELCO's 2006 calendar test year rate case, the commission will instruct Applicants and the Consumer Advocate to submit a procedural schedule for the commission's review and consideration.

<u>Order</u>

THE COMMISSION ORDERS:

1. Within thirty (30) days from the date of this Order, the Parties shall submit to the commission a stipulated procedural schedule, incorporating their agreed upon schedule with respect to this proceeding. If they are unable to stipulate to such a schedule, each Party shall submit a proposed procedural schedule for the commission's consideration by the same date.

On December 13, 2005, in Docket No. 05-0315, HELCO filed a notice of intent to file an application for a general rate increase on or after March 15, 2006, but no later than June 30, 2006. HELCO simultaneously filed a motion to approve its use of a 2006 calendar test year in connection with its application, which was granted.
