ORDER

By this Order, the commission, on its own motion, reopens this docket and vacates Order No. 22172, filed on December 8, 2005, as described herein.

On December 8, 2005, the commission approved the surrender of certificate of authority ("COA") 01-0128, issued to GE BUSINESS PRODUCTIVITY SOLUTIONS, INC. ("GEBPS"), in response to GEBPS' letter, filed on September 6, 2005.<sup>1</sup>

By letter dated January 27, 2006, BUSINESS PRODUCTIVITY SOLUTIONS, INC. ("BPS") seeks to vacate Order No. 22172. BPS explains that:

1. On March 31, 2005, GEBPS transferred COA 01-0128 to BPS, following the commission's approval.<sup>2</sup>

2. BPS is the present holder of COA 01-0128.<sup>3</sup>

3. GEBPS' letter, filed on September 6, 2005, was inadvertently misconstrued in that COA 01-0128 "was no longer GEBPS' to surrender."<sup>4</sup> In effect, GEBPS had no authority to surrender BPS' COA 01-0128.

Based on the foregoing, the commission, on its own motion, reopens this docket and vacates Order No. 22172.

THE COMMISSION ORDERS:

1. Order No. 22172, filed on December 8, 2005, is vacated.

2. This docket is closed, unless ordered otherwise by the commission.
