DECISION AND ORDER

By this Decision and Order, the commission vacates Order No. 21275, filed on September 7, 2004, in the matter of BUEHNER FRY, INC. ("Respondent").

I.

History

Pursuant to Hawaii Revised Statutes § 269-30, the commission ordered Respondent to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on October 6, 2004, to show cause why Respondent's certificate of authority should not be suspended or revoked for failure to pay the public utility fee ("Fee") that was due on December 31, 2003.

On September 27, 2004, Respondent paid its Fee that was due on December 31, 2003.

II.

Findings and Conclusions

The commission finds that Respondent has fully complied, although belatedly, with the commission's applicable laws, rules, and regulations, and concludes that Order No. 21275, filed on September 7, 2004, should be vacated.

1. Order No. 21275 is vacated.
2. This Docket is closed unless otherwise ordered by the commission.


