ORDER

By this Order, the commission revokes certificate of public convenience and necessity no. 1701-C ("Certificate No. 1701-C"), held by EASY TRANSPORTATION COMPANY, INC., dba EASY TRANSPORT COMPANY ("Petitioner").

I.

Background

By Order No. 21580, filed on February 3, 2005, the commission placed Certificate No. 1701-C on inactive status for a period of one year until January 23, 2006. In the order, the commission informed Petitioner that if Certificate No. 1701-C was not reactivated prior to the expiration of the period of inactivity, i.e., by January 23, 2006, the commission would deem it to be abandoned and revoked, as required by Hawaii Revised Statutes § 271-19(b).

Findings and Conclusions

Certificate No. 1701-C was not reactivated prior to the expiration of the period of inactivity, i.e., by January 23, 2006. We, thus, find that there is good cause to revoke Certificate No. 1701-C.
