ORDER

By this Order, the commission revokes certificate of public convenience and necessity no. 1572-C ("Certificate No. 1572-C"), held by CHUANLEI LU, dba LC HAWAII TRAVEL ("Petitioner").

I.

Background

By Order No. 21537, filed on January 11, 2005, the commission placed Certificate No. 1572-C on inactive status for a period of three hundred and twenty-five (325) days until January 15, 2006. In the order, the commission informed Petitioner that if Certificate No. 1572-C was not reactivated prior to the expiration of the period of inactivity, i.e., by January 15, 2006, the commission would deem it to be abandoned and revoked, as required by Hawaii Revised Statutes § 271-19(b).

II.

Findings and Conclusions

Certificate No. 1572-C was not reactivated prior to the expiration of the period of inactivity, i.e., by January 15, 2006. We, thus, find that there is good cause to revoke Certificate No. 1572-C.

1. Certificate No. 1572-C is revoked.


