DECISION AND ORDER

By this Decision and Order, the commission vacates Order No. 22750, filed on August 15, 2006, in the matter of ENCOMPASS COMMUNICATIONS, LLC ("Respondent").

I.

History

Pursuant to Hawaii Administrative Rules § 6-80-91, Hawaii Revised Statutes § 269-30, and Order No. 20193, the commission ordered Respondent to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on September 28, 2006, to show cause why Respondent's certificate of authority should not be suspended or revoked for failure to file an annual financial report ("AFR") for 2004, and pay the telecommunications relay services ("TRS") fund contribution that was due on July 26, 2003 and July 26, 2004.

On August 25, 2006, Respondent filed its 2004 AFR, and paid the TRS fund contribution that was due on July 26, 2003 and July 26, 2004.

II.

Findings and Conclusions

The commission finds that Respondent has fully complied, although belatedly, with the commission's applicable laws, rules, and regulations, and concludes that Order No. 22750, filed on August 15, 2006, should be vacated.




THE COMMISSION ORDERS:

2. This Docket is closed unless otherwise ordered by the commission.


