ORDER

By this Order, the commission approves HAWAIIAN TELCOM SERVICES, COMPANY, INC.'s ("HTSC") withdrawal of its application, filed on October 23, 2006, without prejudice, and closes this docket.¹

I.

Withdrawal of Application

On October 23, 2006, HTSC filed its Application, seeking to: (1) offer the myChoicesm Value, myChoicesm Freedom, and myChoicesm Freedom Plus bundled plans to residential customers in the State of Hawaii; and (2) amend its tariff to include Rule 3.6.15, governing the Call Moresm Custom Bundled Service.

¹HTSC's Application; Exhibit A; Verification; and Certificate of Service, filed on October 23, 2006 (collectively, the "Application"). HTSC served a copy of its Application upon the Department of Commerce and Consumer Affairs, Division of Consumer Advocacy, an ex officio party to this proceeding, pursuant to Hawaii Revised Statutes § 269-51 and Hawaii Administrative Rules § 6-61-62(a).

On November 15, 2006, HTSC filed a withdrawal of its Application, "request[ing] that the Commission close Docket No. 2006-0424."²

The commission approves HTSC's withdrawal of its Application without prejudice, and closes this docket.

Orders

THE COMMISSION ORDERS:

1. The withdrawal of HTSC's Application, filed on October 23, 2006, is approved, without prejudice.
2. This docket is closed unless ordered otherwise by the commission.
