<u>ORDER</u>

By this Order, the commission orders that the application filed by KINGSMEN TRUCKING & EQUIPMENT SERVICES LLC ("Applicant") on May 11, 2006, is dismissed without prejudice and this docket is closed.

I.

Application for Common Carrier Authority

On May 11, 2006, Applicant filed an application requesting a certificate of public convenience and necessity to operate as a common carrier of property by motor vehicle over irregular routes on the island of Maui in the general commodities, specific commodities (water hauling), and dump truck classifications.

By a notice of dismissal dated October 6, 2006, we informed Applicant of our intent to dismiss the application without prejudice because of Applicant's failure to respond to the commission's requests for information. Applicant was further advised that any objection to the dismissal of its application

must be submitted in writing and filed not later than ten (10) days from the date of the notice, and that if an objection was not filed, the commission would issue an order dismissing the application.

On October 12, 2006, Applicant filed a timely objection to the dismissal of its application stating that there was a problem in obtaining a Tax Clearance Certificate ("TCC") and requested a ninety (90)-day extension of time to do so. On October 12, 2006 and October 19, 2006, Applicant submitted all the other documents requested by the commission.

II.

Findings and Conclusions

The requested ninety (90)-day extension of time has passed and Applicant has not submitted its TCC. We, thus, find that there is good cause to dismiss the application in this docket.

III.

Orders

THE COMMISSION ORDERS:

The application filed by Applicant on May 11, 2006, is dismissed without prejudice and this docket is closed unless otherwise ordered by the commission.
