ORDER

By this Order, the commission approves the revised tariff sheets and rate schedules filed by KRWC CORPORATION, dba KOHALA RANCH WATER COMPANY ("KRWC") on May 2, 2007. Applicant's revised tariff sheets and rate schedules shall take effect immediately from the date of this Order.

I.

Revised Tariff Sheets and Rate Schedules

By Decision and Order No. 23404, filed on May 1, 2007, the commission approved the Stipulation of Settlement Agreement in Lieu of Rebuttal Testimonies, filed on March 23, 2007, by KRWC and the DIVISION OF CONSUMER ADVOCACY, DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS. Decision and Order No. 23404 also instructed Applicant to file its revised tariff sheets and rate schedules, reflecting the initial rates and charges, and changes to its Rules and Regulations authorized by Decision and Order No. 23404, within ten days of the date of Decision and Order No. 23404.

On May 2, 2007, KRWC timely filed its revised tariff sheets and rate schedules.¹ The commission has reviewed KRWC's revised tariff sheets and rate schedules, and finds that they are in compliance with Decision and Order No. 23404. The commission accordingly approves KRWC's revised tariff sheets and rate schedules, which shall become effective immediately as of the date of this Order. Applicant is instructed to promptly file its revised tariff sheets and rate schedules, consistent with the terms of this Order, with the applicable Order No. and effective date showing on each page.

II.

Orders

THE COMMISSION ORDERS:

1. KRWC's revised tariff sheets and rate schedules, filed on May 2, 2007, are approved, and shall take immediate effect from the date of this Order.

2. Applicant shall promptly file with the commission its revised tariff sheets and rate schedules to reflect the applicable Order No. and effective date on each page.
