## ORDER

By this Order, the commission vacates Order No. 23433, filed on May 14, 2007, and reinstates Decision and Order No. 23083, in the matter of RICK KAMAKAOKALANI MIKAELE, dba PRINCIPLE LIMOUSINE ("Petitioner").

## Background

On September 19, 2006, Petitioner filed an application seeking commission approval to extend his authority under certificate of public convenience and necessity number 5746-C to include the 8-to-25 passenger classification on the island of Hawaii, excluding Waipio Valley. By Decision and Order No. 23083, filed on November 27, 2006, the commission granted Petitioner's request, upon condition that Petitioner file certain required documents with the commission. By Order No. 23433, filed on May 14, 2007, the commission vacated Decision and Order No. 23083 for Petitioner's failure to comply with the

commission's requirements set forth in Decision and Order No. 23083.

On May 17, 2007, Petitioner filed a timely motion for reconsideration of Order No. 23433 and filed the requisite documents requested by Decision and Order No. 23083.

The commission finds that Respondent has fully complied, although belatedly, with the requirements set forth in Decision and Order No. 23083, and, thus, finds good cause in this particular instance to reconsider and set aside Order No. 23433.
