STIPULATED ORDER

By this Stipulated Order, the Public Utilities Commission of the State of Hawaii (the **Commission**), grants the Parties' request for an extension of time, from July 6, 2007, to July 20, 2007, to file their settlement agreement in this proceeding. The Parties filed their request on July 6, 2007, in a Stipulated Motion for Time Extension.

I.

Background

In accordance with Order No. 23311, which sets forth the procedural schedule governing this proceeding, as amended by (1) the Commission's letter dated April 10, 2007, (2) Order No. 23504 filed on June 22, 2007, and (3) Order No. 23532 filed on July 2, 2007, the deadline for the Parties to file their settlement agreement is July 6, 2007.

By letter dated June 28, 2007, the Parties informed the Commission that they settled, in principle, all of the issues in this proceeding. The Parties also requested an

extension of time, from June 29, 2007, to July 6, 2007, to file their settlement agreement. The Commission granted their request by Order No. 23532.

The Parties now request a further extension of time, from to July 6, 2007, to July 20, 2007, to submit a settlement agreement in this proceeding.

## II.

### Discussion

Hawaii Administrative Rules § 6-61-23(a)(1) provides the Commission with the discretion, for good cause shown, to enlarge a period by which a required act must be completed, if a written request is made before the expiration of the period originally prescribed. The Parties seek an extension of time, from July 6, 2007, to July 20, 2007, to file their settlement agreement. The Parties state that (1) they have continued to dialogue and reached substantial agreement via a lengthy meeting held on July 3, 2007, as well as through numerous telephone conferences and exchanges of data via e-mail, and are reconciling matters that have arisen in the course of reviewing drafts of their settlement agreement, and (2) this reconciliation has taken longer than anticipated because, unlike many other rate case proceedings, the details flowing from their global agreement must reflect allocations between Young Brothers' intra- and interstate operations in its cost of service results.

The Commission finds good cause in this instance to enlarge the deadline, from July 6, 2007, to July 20, 2007, for the Parties to file their settlement agreement, and their request is granted and so ordered.




