ORDER

The commission takes official notice, pursuant to Hawaii Administrative Rules § 6-61-48, of a copy of a Certificate of Death, filed at the commission on July 13, 2007, which notified the commission that SHIRLEY LANDON NEWELL ("Ms. Newell") passed away on June 17, 2007. Ms. Newell, dba WINDWARD AIRPORT SHUTTLE, held certificate of public convenience and necessity no. 1353-C ("Certificate No. 1353-C"), which authorized the transportation of passengers by motor vehicle in the 1-to-7 passenger classification over irregular routes on the island of Oahu, limited to serving the windward areas (Kaneohe and Kailua) to the Honolulu International Airport. As Ms. Newell has passed away, the commission finds good cause to terminate Certificate No. 1353-C as of the date of Ms. Newell's death.




