By this Order, the commission terminates certificate of public convenience and necessity no. 842-C ("Certificate No. 842-C"), held by H & M COMPANY, INC., dba H & M SHUTTLE SERVICE ("Petitioner"), effective from the date of this Order.

I.

Request to Surrender Common Carrier Authority

On August 1, 2007, Petitioner filed a letter requesting commission approval to voluntarily surrender its authority under Certificate No. 842-C. Certificate No. 842-C authorizes Petitioner to transport passengers by motor vehicle over irregular routes on the island of Oahu in the 8-to-25 passenger classification.

II.

Findings and Conclusions

In accordance with Hawaii Revised Statutes ("HRS") § 271-19, operating authority under a certificate of

public convenience and necessity may be terminated upon application of the holder. The commission finds good cause to grant Petitioner's request to terminate its authority.

<u>Orders</u>

THE COMMISSION ORDERS:

- 1. Petitioner's authority to transport passengers under Certificate No. 842-C is terminated, effective from the date of this Order.
- 2. Petitioner shall remove any markings from the vehicles used in its operations. Petitioner shall comply with the foregoing requirement within fifteen (15) days from the date of this Order.
- 3. If Petitioner fails to comply with the foregoing requirement within the time period specified, it may be subject to penalties pursuant to HRS § 271-27.
- 4. This docket is closed unless otherwise ordered by the commission.
