ORDER

By this Order, the commission: (1) acknowledges the submittal of the compliance filings made by DIRECT TELEPHONE COMPANY, INC. ("DTC"); and (2) orders DTC to file its revised tariff and informational filings with an appropriate issued date and an effective date of August 20, 2007.

I.

Compliance Filings

In Decision Order No. 23552, and filed July 20, 2007, commission the approved the transfer SUMMIT COMMUNICATIONS, INC.'s ("Summit") shared tenant services ("STS") assets and operations to DTC and authorized DTC to provide STS under the same terms and conditions and "tariff" as once offered by Summit, provided that DTC adhered to certain regulatory conditions. In particular, the commission directed (1)fully comply with the requirements of Hawaii Administrative Rules ("HAR") § 6-80-91 by submitting its 2006 annual financial report ("2006 AFR"); and (2) submit copies of its tariff and informational filings made in Docket No. 04-0259, on March 28, 2005 (as amended) reflecting, other things: (a) DTC's name as opposed Integrated Communications, LLC's as the provider of the STS; (b) only services that DTC had been authorized to provide in Interim Decision and Order No. 20410, filed on August 29, 2003 ("Interim Order"); and (c) appropriate issued and effective dates, as applicable, within 30 days of the date of the decision and order.

On August 20, 2007, DTC submitted its 2006 AFR and copies of its tariff and informational filings in compliance with Decision and Order No. 23552. Upon review, however, the commission notes that the filed tariff and informational filings do not specify issued and effective dates as directed. The commission considers this omission to be inadvertent and provides DTC with specific guidance to comply with the commission's order.

Rate schedules for providers of STS are effective upon filing. Thus, the commission finds it appropriate to determine that DTC's tariff and informational filings, which include DTC's rates for service, should also be effective upon filing (i.e., August 20, 2007, the date that DTC initially filed its tariff and informational filings). Further, the commission notes that DTC had been providing services basically under these same tariff and informational filings since it received temporary authority to

provide STS under the Interim Order. Thus, the commission finds it reasonable to require DTC to file revised tariff informational filings with an appropriate issued date and an effective date of August 20, 2007, within 15 days of the date of this Order, in accordance with Decision and Order No. 23552 and the commission requirements herein. Similar to the commission's directive in Decision and Order No. 23552, DTC should file an original and three copies of its revised tariff and informational filings and two copies of the same should be filed with the DIVISION OF CONSUMER ADVOCACY, DEPARTMENT OF COMMERCE AFFAIRS ("Consumer Advocate")³ consistent CONSUMER with HAR § 6-61-18.

II.

<u>Orders</u>

THE COMMISSION ORDERS:

1. Within 15 days of the date of this Order, DTC shall file an original and three copies of its revised tariff and informational filings with an appropriate issued date and an effective date of August 20, 2007, in accordance with Decision and Order No. 23552 and the commission's requirements herein. Two copies of the same shall be served on the Consumer Advocate consistent with HAR § 6-61-18.

Unless ordered otherwise by the commission, DTC's revised tariff and information filings, with the applicable issued and effective dates, shall be deemed approved upon filing to the extent it complies with Decision and Order No. 23552 and the commission's requirements herein, and this docket shall be closed.
