#### ORDER

By this Order, the application filed by DANIEL K. ILAE, dba DK'S TRUCKING & EXCAVATION ("Applicant"), on December 14, 2006, is dismissed without prejudice and this docket is closed.

## Application for Common Carrier Authority

On December 14, 2006, Applicant filed an application requesting a certificate of public convenience and necessity to operate as a common carrier of property by motor vehicle over irregular routes on the island of Oahu in the general commodities and dump truck classifications.

By a notice of dismissal dated August 13, 2007, we informed Applicant of our intent to dismiss the application without prejudice because of Applicant's failure to respond to the commission's request for information. Applicant was further advised that any objection to the dismissal of his application must be submitted in writing and filed not later than ten (10) days from the date of the notice, and that if an objection was not filed, the commission would issue an order dismissing the application.
