DECISION AND ORDER

By this Decision and Order, the commission vacates Order No. 23775, filed on October 26, 2007, in the matter of NORTH SHORE WASTEWATER TREATMENT, LLC ("Respondent").

I.

History

By Order No. 23775, filed on October 26, 2007, the commission ordered Respondent to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on November 20, 2007, to show cause why Respondent's certificate of public convenience and necessity should not be suspended or revoked for failure to file an annual financial report ("AFR") for the year 2005, and pay a public utility fee ("Fee") that was due on July 31, 2006, and December 31, 2006, pursuant to Ordering Paragraph No. 5 of Decision and Order No. 21864, filed on

June 14, 2005, in Docket No. 04-0298, and Hawaii Revised Statutes § 269-30.

On October 24, 2007, Respondent paid the Fee that was due on July 31, 2006 and December 31, 2006, and on November 6, 2007, filed its 2005 AFR.

II.

Findings and Conclusions

The commission finds that Respondent has fully complied, although belatedly, with the commission's applicable orders, laws, rules, and regulations, and concludes that Order No. 23775, filed on October 26, 2007, should be vacated.




1. Order No. 23775 is vacated.




