#### ORDER

By this Order, the commission vacates Decision and Order No. 23271 and closes this docket.

## Application for Contract Carrier Authority

On February 22, 2007, in Decision and Order No. 23271, the commission approved the application of ABOVE AND BEYOND DELIVERY HAWAII, INC. ("Applicant") for a permit to operate as a contract carrier of property by motor vehicle over irregular routes on the island of Oahu in the general commodities classification pursuant to a contract with AmerisourceBergen. We also: (1) ordered Applicant, as a condition to our approval of the application, to comply with all commission requirements for contract carriers, including submitting certain documents within one hundred and twenty (120) days of the issuance of the decision and order; and (2) notified Applicant that failure to timely comply with the commission's requirements would constitute cause for the commission to vacate the Decision and Order.

We served Applicant with a copy of the Decision and Order by mail, postage prepaid, on the same day that Decision and Order was issued, in accordance SS 6-61-21 and Hawaii Administrative Rules 6-61-122. Additionally, we sent а letter to Applicant, February 2, 2007, which reiterated the commission's requirements and specified June 22, 2007, as the deadline for compliance.

On June 19, 2007, Applicant filed a request for a sixty (60)-day extension to comply. The request was approved on July 5, 2007, allowing Applicant until August 22, 2007 to comply.

## Findings and Conclusions

The extended due date has passed, and Applicant has not complied with the requirements set forth in Decision and Order No. 23271. The commission, thus, determines that Decision and Order No. 23271 should be vacated.

Decision and Order No. 23271 is vacated and this docket is closed unless otherwise ordered by the commission.
