DECISION AND ORDER

By this Decision and Order, the commission vacates Order No. 23770, filed on October 26, 2007, in the matter of MEDEIROS TRUCKING SERVICE, INC. ("Respondent").

I.

<u>History</u>

By Order No. 23770, filed on October 26, 2007, the commission ordered Respondent to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on November 20, 2007, to show cause why Respondent's certificate of public convenience and necessity number 243-C should not be suspended or revoked for failure to pay penalties and interest in the amount of \$5,918.72 that were assessed, pursuant to Hawaii Revised 271-27(i), Statutes 8 and Hawaii Administrative Rules \S 6-62-24(b)(c) and 6-62-42(d), for the late filing of its annual financial reports and annual motor carrier gross revenue

fees for the years 2004 and 2005. On November 20, 2007, Respondent paid its penalties and interest in the amount of \$5,918.72.

II.

Findings and Conclusions

The commission finds that Respondent has fully complied, although belatedly, with the motor carrier laws, rules, and regulations, and concludes that Order No. 23770, filed on October 26, 2007, should be vacated.
