Notice of Failure to Comply With Hawaii Revised Statutes and Commission's Regulations; Order to Show Cause Why Respondent's Operating Authority Should Not Be Suspended or Revoked. Docket No. 2007-0256 Order No. 23905

### **ORDER**

By this Order, the commission suspends certificate of public convenience and necessity number 1785-C ("Certificate No. 1785-C"), held by ISLAND NETWORK SERVICES, LLC, dba INS TOURS ("Respondent"), for a period of three (3) months.

I.

## Procedural History

By Order No. 23757, filed on October 24, 2007, the commission ordered Respondent to appear at 465 South King Street, 96813, Room Honolulu, Hawaii at 9:00 a.m., November 20, 2007, to show cause why Respondent's Certificate No. 1785-C should not be suspended or revoked for failure to pay the civil penalty \$1,000.00 associated of with Citation No. 0921. In its order, the commission notified

Respondent that Certificate No. 1785-C would be suspended or revoked if it failed to appear at the scheduled hearing.

On November 20, 2007, Respondent failed to appear before the commission's hearing officer. As a result, the hearings officer recommended that: (1) Respondent be found in for failure the default to appear at hearing, (2) Respondent's Certificate No. 1785-C be suspended for a period of three (3) months and thereafter be revoked if Respondent fails pay the civil penalty of \$1,000.00 associated with Citation No. 0921.

### Findings and Conclusions

Based on the entire record, the commission finds that Respondent's failure to appear at the November 20, 2007 hearing constitutes a default in accordance with Hawaii Administrative Rules § 6-68-23. Accordingly, because the commission can assume the facts alleged in Order No. 23757 are true in the event of a default, and such facts are in violation of the applicable laws, rules, and regulations noted above, the commission concludes that

Pursuant to Hawaii Administrative Rules § 6-61-21, service is deemed complete upon properly stamping, addressing, and mailing the order to Respondent's last known address, or to Respondent's attorney. Additionally, pursuant to Hawaii Revised Statutes § 91-9.5, the commission provided Respondent with notice of hearing via statewide publication in newspapers of general circulation on October 26, 2007 and November 2, 2007.

Respondent's Certificate No. 1785-C should be suspended for a period of three (3) months and thereafter be revoked if Respondent fails to pay the civil penalty of \$1,000.00 associated with Citation No. 0921.

#### Orders

#### THE COMMISSION ORDERS:

- Certificate No. 1785-C is suspended for a period 1. of three (3) months, effective from the date of this Order.
- If Respondent fails to pay the civil penalty of \$1,000.00 associated with Citation No. 0921 by the time the suspension period has expired, i.e., three (3) months from the date of this Order, Certificate No. 1785-C shall be revoked.
