ORDER VACATING DECISION AND ORDER NO. 24187

By this Order, the commission vacates Decision and Order No. 24187 and closes this docket.

I.

Application for Common Carrier Authority

On February 1, 2008, DAVID T. PHAN ("Applicant") filed an application requesting a certificate of public convenience and necessity ("Certificate") to operate as a common carrier of passengers by motor vehicle over irregular routes on the island of Oahu in the 8-to-25 passenger classification. By Decision and Order No. 24187, filed on May 8, 2008, the commission granted Applicant a Certificate subject to certain requirements.

On May 29, 2008, Applicant filed a request to withdraw his application, stating that he will reapply for a Certificate in the 1-to-7 passenger classification.¹ In light of this

request, the commission finds good cause to vacate Decision and Order No. 24187, and to close this docket.
