By this Order, the commission vacates Decision and Order No. 24041 and closes this docket.

I.

Application to Transfer Common Carrier Authority

On November 8, 2007, COURIER CORPORATION OF HAWAII ("Transferor") filed an application requesting commission approval to transfer certificate of public convenience and necessity number 80-C ("Certificate No. 80-C") to WSA, LLC ("Transferee"). By Decision and Order No. 24041, filed on February 19, 2008, the commission approved the transfer, subject to certain conditions.

On June 6, 2008, Transferor filed a request to withdraw its application, as it decided not to transfer Certificate No. 80-C to Transferee.¹ In light of this request, the

THE COMMISSION ORDERS:


Decision and Order No. 24041 is vacated, and this docket is closed unless otherwise ordered by the commission.


