ORDER DISMISSING APPLICATION

By this Order, the commission dismisses the application filed by MOLINA'S TRUCKING LLC ("Applicant") on March 11, 2008, and amended on April 9, 2008, and closes this docket.

I.

Application for Common Carrier Authority

By application filed on March 11, 2008, and amended on April 9, 2008, Applicant requests a certificate of public convenience and necessity to operate as a common carrier of property by motor vehicle over irregular routes on the island of Oahu in the general commodities and dump truck classifications.

By a notice of dismissal dated August 27, 2008, we informed Applicant of our intent to dismiss the application without prejudice because of Applicant's failure to respond to the commission's request for information. Applicant was further advised that any objection to the dismissal of its application must be submitted in writing and filed not later than ten (10) days from the date of the notice, and that if an objection was

not filed, the commission would issue an order dismissing the application.

II.

Findings and Conclusions

Applicant did not object to the dismissal of its application within the ten (10)-day time period. We, thus, find that there is good cause to dismiss the application in this docket.

III.

Order

THE COMMISSION ORDERS:


The application filed by Applicant on March 11, 2008, and amended on April 9, 2008, is dismissed without prejudice and this docket is closed unless otherwise ordered by the commission.


