<u>ORDER</u>

By this Order, the commission approves the voluntary surrender of AZTECA MOBILE, L.L.C.'s ("Petitioner") certificate of registration ("COR").

I.

Background

Petitioner holds a COR to provide prepaid resold wireless telecommunications services within the State of Hawaii ("State"). By letter dated March 12, 2008, Petitioner seeks to voluntarily surrender its COR, representing that it "does not have any customers in Hawaii and has ceased offering telecommunications service in the state. "On November 19, 2008, Petitioner fully complied with the commission's directive to file its 2007 and 2008 Annual Financial Reports and pay the applicable public utility fees.

Discussion

Hawaii Administrative Rules ("HAR") § 6-80-123(c) provides in relevant part that for any telecommunications carrier whose entry into the intrastate telecommunications market is preempted by federal law, said carrier shall, not later than the proposed effective before thirty days date contemplated abandonment or discontinuance of service, provide a written notice of [its] intent to abandon or discontinue service commission, the consumer advocate, and affected customers."

The commission approves Petitioner's request to surrender its COR to provide CMRS on a resold basis within the State, consistent the HAR \S 6-80-123(c).

<u>Orders</u>

THE COMMISSION ORDERS:

- 1. Petitioner's request to surrender its COR to provide prepaid wireless telecommunications services within the State is approved, effective from the date of this Order.
- 2. This docket is closed unless ordered otherwise by the commission.
