ORDER AMENDING DECISION AND ORDER FILED ON DECEMBER 4, 2008

I.

By the Decision and Order filed on December 4, 2008, JACKIE'S BACKHOE SERVICE INCORPORATED ("Applicant") was granted a certificate of public convenience and necessity to operate as a common carrier of property by motor vehicle over irregular routes on the island of Oahu in the general commodities and dump truck classifications.

On December 19, 2008, Applicant filed a letter requesting that its authority in the general commodities classification be surrendered. Accordingly, we find good cause to grant Applicant's request and amend the Decision and Order to reflect such surrender of authority.

II.

<u>Orders</u>

THE COMMISSION ORDERS:

- 1. Applicant's request to surrender its authority in the general commodities classification is granted.
- 2. The Decision and Order filed on December 4, 2008 is amended consistent with the terms of this Order. Specifically, ordering paragraph 1 of the Decision and Order is amended as follows:

"Applicant is granted a Certificate to operate as a common carrier of property by motor vehicle over irregular routes on the island of Oahu in the dump truck classification."

In all other respects, the Decision and Order filed on December 4, 2008 remains unchanged.
